

## 华泰财险附加首席保险人批单（CB 版）

兹经双方了解并同意，对于任何**赔偿请求**、**可赔情形**及其后续处理情况的通知，适用以下规定：

1. 明细表指定保险人为本保险合同的首席保险人；
2. 由首席保险人全权负责接受有关**赔偿请求**及**可赔情形**的通知、指定共保人的代理律师、确认同意**被保险人**抗辩律师的指定及处理**赔偿请求**和**可赔情形**。
3. 确定发生的**抗辩费用**是否应予以保险赔偿及赔偿金额需经过所有共保人的同意。如果所有共保人未能在首席保险人决定是否赔偿在明细表约定期间内达成一致，则首席保险人的意见将作为所有共保人的最终及有约束力的决定；
4. 任何就**抗辩费用**除外的**损失**提议的和解或赔付方案须经所有共保人同意。如果所有共保人未能在首席保险人提出和解或赔付的方案后在明细表约定期间内内达成一致，则首席保险人的意见将作为所有共保人的最终及有约束力的决定；
5. 首席保险人应当及时将理赔处理进展告知共保人，并于收到相关信息及资料后的在明细表约定期间内内，将其提供给共保人。

本保险合同的其他条款维持不变。

## G06 LEAD INSURER ENDORSEMENT

It is hereby understood and agreed that with respect to any notice of **Claim** or **Circumstance** and any subsequent **Claims** or **Circumstances** handling, the following applies:

1. [ ] shall be designated the leader of this policy (herein after referred to as "the Leader").
2. The Leader shall be solely responsible for the acceptance of notice of **Claims** and **Circumstances**, appointment of counsel to represent co-insurers, agreeing to the appointment of any defense counsel for the **Insureds**, and the general management of the **Claim** or **Circumstance**.
3. When determining whether coverage applies and to what extent it applies with respect to the incurring of **Defense Costs**, any determination shall be made by all co-insurers. Should all co-insurers fail to reach agreement on coverage within [ ] business days following a recommendation provided by the Leader, the Leader's recommendation shall be final and binding on all of the co-insurers.
4. Any proposed settlement or proposed payment of **Loss** other than **Defense Costs** shall be agreed by all co-insurers. Should all co-insurers fail to reach agreement on payment within [ ] business days following a

recommendation provided by the Leader, the Leader's recommendation shall be final and binding on all co-insurers.

5. The Leader shall keep the co-insurers informed of all developments and provide to them all relevant documentation and information within [ ] business days of receipt of such information and documentation.

In all other respects this policy remains unaltered.
