如果**管理团队**的成员在保险期间内发现有合理怀疑或确认发生**网络事故或营业中断事故**,且**被保险人**按照本保险合同第二十四条的规定通知**保险人**的,**保险人**将代**被保险人**支付为减少该等事故造成的损害、后果或费用而在发现该等事故后首个 48 小时内产生的**紧急应急响应费用**。

2. 本批单项下"紧急应急响应费用"适用以下定义:

紧急应急响应费用:是指下述事项发生的合理必要费用(仅适用于本保险合同第六条):

- 1、通过安达应急响应中心聘请网络事故应急响应管理方提供服务,对**被保险人**有合理怀疑或确认发生的**网络事**故或**营业中断事故**进行协调响应;
- 2、通过安达应急响应中心聘请第三方计算机取证公司,确定**被保险人**有合理怀疑或确认发生的**网络事故或营业中断事故**的原因及范围,并采取措施停止、逆转或修复该等**网络事故**或**营业中断事故**产生的后果。

紧急应急响应费用应计入保险明细表中载明适用于本保险合同第三条项下应急响应的分项限额,而非额外赔偿的费用,该适用的分项限额将因紧急应急响应费用的赔偿而相应减少直至用尽。

- 2. The section titled *Insuring Agreement Extensions* is amended by deleting the clause for Emergency Incident Response and replacing it with the following:
 - 2.1 Emergency Incident Response
 - **Emergency Incident Response Expenses** incurred within the first 48 hours immediately following the discovery of an actual or reasonably suspected **Cyber Incident** or **Business Interruption Incident** by any **Control Group** member during the **Policy Period** and reported to **us** pursuant to General Condition 5.10 Notification.
- 3. The section titled *General Definitions* is amended by deleting the definition of **Emergency Incident Response Expensese** and replacing it with the following:

Emergency Incident Response Expenses, applicable to Insuring Agreement Extension 2.1 only, means those reasonable and necessary expenses:

- A. to retain the services of the cyber incident response manager assigned through contacting the *Chubb Cyber Incident Response Centre* to coordinate response to **your** actual or reasonably suspected **Cyber Incident** or **Business Interruption Incident**;
- B. to retain a third party computer forensics firm assigned through contacting the *Chubb Cyber Incident Response Centre* to determine the cause and scope of **your** actual or reasonably suspected **Cyber Incident** or **Business**Interruption Incident and to initiate the process to stop, reverse or remediate the effects of such **Cyber Incident** or **Business Interruption Incident**.

Emergency Incident Response Expenses shall be a part of and not in addition to the applicable **Aggregate Limit** shown in the **Schedule** for Incident Response as provided for under Insuring Agreement 1.1, and shall reduce and may completely exhaust such applicable **Aggregate Limit**.

All other terms and conditions of this Policy remain unchanged.
