

华泰财险附加保护个人信息扩展条款（CB版）

兹经双方了解并同意，保险人同意代**被保险人**给付基于**信息使用者**违反**信息保护**的标准或准则而提出的**索赔**（其第一次提出时间是在**保险期间内**或在**延长索赔通知期限内**，而且**被保险人**依法应负**赔偿责任**的）导致的所有**损失**。

就本扩展条款而言：

信息是指**信息使用者**为达到**合法**的目的而收集及持有可以识别**对象**身份的**个人信息**。

信息收集是指**合法**的收集或编制与**对象**有关的信息，以让**信息使用者**的**档案系统**包含该**信息**。

信息处理是指**合法**的储存或使用与**对象**有关的信息，以让**信息使用者**的**档案系统**包含该**信息**。

信息保护是指符合或遵守以下与**信息收集**或**信息处理**有关的：

1. 法定监管标准或对**信息使用者**有约束力的**准则**；或
2. **信息使用者**根据官方认可的行为守则而发布的标准。

对象是指其**信息**被**信息使用者**或其**代理人**收集或使用的**自然人**。

信息使用者是指进行**信息收集**或**信息处理**的**机构**。

合法是指根据适用的法律，**合法**、**明确**及**恰当地**收集或处理**信息**。

档案系统是指**信息使用者**用于存储和索引**资料**的系统，且该系统是受到适用的**数据保护**和/或**隐私法**所规范的。

本保险单的其他条款维持不变。

K05 DATA PROTECTION EXTENSION

It is understood and agreed that the Company shall pay, on behalf of an **Insured**, all **Loss** which such **Insured** becomes legally obligated to pay on account of any **Claim** first made against such **Insured** during the **Policy Period** or any Extended Reporting Period, for any breach of **Data Protection** by the **Data User**.

For the purpose of this extension:

Data means any personal data which relates to any **Data Subject** held by the **Data User** which is collected for a **Legitimate** purpose and enables identification of the **Data Subject**.

Data Collection means the **Legitimate** collection or compiling of information in relation to a **Data Subject** with the intent that such **Data** be included in the **Data User's Relevant Filing System**.

Data Processing means the **Legitimate** storage or use of information in relation to a **Data Subject** with the intent that such **Data** be included in the **Data User's Relevant Filing System**.

Data Protection means maintaining compliance with:

1. regulatory standards imposed by law or by binding code upon the **Data User**; or
2. standards published and disseminated by the **Data User** pursuant to an officially recognized code of conduct,
relating to **Data Collection** or **Data Processing**.

Data Subject means any natural person whose **Data** has been collected or processed by or on behalf of a **Data User**.

Data User means the **Organisation** that conducts **Data Collection** or **Data Processing**.

Legitimate means the lawful, specific, and relevant collection or processing of **Data** as specified under applicable law.

Relevant Filing System means the **Data User's** system for storage and indexing of **Data** as regulated by applicable data protection and/or privacy law.

In all other respects this policy remains unaltered.
